## Applicant Information

### Audition Process

There are two rounds of auditions. Preliminary auditions will be held in London, Birmingham, Cardiff, Glasgow and Manchester during January 2019. Recall auditions will be held in London on 22, 23 February and 2 March 2019.

Auditionees should aim to arrive at least 30 mins before their audition time. Auditions last for approximately 10 minutes. An accompanist will be provided.

### Repertoire

Auditionees should prepare three contrasting arias, including one in English (this can be a translation).

### Audition Fee

As part of the application, auditionees will be required to pay an audition fee of £20 by on-line payment. Payments should be made into the following account with the appropriate reference:

For singers: "AUD" and surname, for example "AUDSMITH"

Auditionees unable to make an on-line payment can pay the fee by cheque made out to "British Youth Opera". Payments from candidates who are not selected to audition will be refunded.

### Financial Matters

BYO charges no fees for its training. Every singer who gains a place in a summer season production or in one of our workshops benefits from a fully-funded placement. In addition to this a subsistence payment is made to every participant in the summer season.

Accommodation in London can be provided for a limited number of successful applicants who do not have a London base and would otherwise be unable to participate.

### Criteria

BYO's primary purpose is to offer operatic experience to singers who have a serious aim of pursuing careers in opera performance, are at the start of their careers, and are new to the profession.

- To that end, in selecting singers for audition, BYO will accept applications from singers of any nationality who are studying full-time at a music college in the United Kingdom.
- BYO will also consider applications from singers who are about to start, or who have recently finished, such study in the United Kingdom.
- BYO may, at its discretion, consider applications from other singers resident in the UK, where such applications contain evidence that the applicant has a serious aim of pursuing a career in opera performance, is at the start of his or her career, and is new to the profession.
